On March 19, 2025 at approximately 0513 hours I, Officer McCallian responded to the GO Corrections Detention Center located at 3130 N Oakland St, City of Aurora, County of Adams, State of Colorado on report of an outside agency assist.

I called the reporting party, Mohamed Bennani [REDACTED] verbally identified, who is the Assistant Facility Administrator at the GO corrections Detention Center. Mohamed informed me that on March 19 at approximately 0035 hours the staff at the facility noticed that two inmates were missing. The last time either inmate was accounted for was on March 18 at 1400 hours during a facility wide count. Mohamed stated on March 18 at 2130 hours the power at the facility went out. When the power went out the back doors of the facility opened up to the soccer field. Mohamed believes that both inmates escaped through the back door when the power went out.

The facility staff started an emergency count when the power went out and discovered that both inmates were missing at 0035 hours. Both inmates were last seen wearing an orange long sleeve top, beige colored pants and black colored Crocs.

Mohamed informed me the cameras are currently down due to the power being out. Mohamed believes once the power is restored he should be able to review the footage from when the power was out. At the time of writing this report the power was still out at the facility and the camera footage was still not available.

The first inmate is, Joel Jose Gonzalez-Gonzalez (DOB: 01/21/1993) verbally identified. Joel has short black hair, brown eyes, weighs 165 lbs, 67 inches tall, has an unspecified tattoo on his right arm and an unspecified tattoo on his left arm. Joel has an emergency contact listed as a [REDACTED] with a phone number of [REDACTED]. I sent Mohamed a link to evidence.com and he said he would upload a photo of Joel to evidence.com. At the time of writing this report Mohamed had not uploaded the photo yet. Joel's country of origin is Mexico.

The second inmate is, Jose Geiland Vido-Romero (DOB: 07/17/2000) verbally identified. Jose has short black hair, brown eyes, weighs 185 lbs, 72 inches tall and no tattoos that Mohamed was aware of. Jose's wife is listed as his emergency contact her name is [REDACTED] and there are two phone numbers listed for her, [REDACTED] and [REDACTED]. Mohamed had no further information on [REDACTED]. I sent Mohamed a link to evidence.com and he said he would upload a photo of Jose to evidence.com. At the time of writing this report Mohamed had not uploaded the photo yet. Jose's country of origin is Venezuela.
